RESOLUTION ESTABLISHING TEMPORARY SPEED LIMIT ON STATE DETOUR (#25-13)

WHEREAS, pursuant to SDCL 32-25-9.1, the Board of County Commissioners may determine and establish speed zones upon all or any part of the highways under its jurisdiction; and

WHEREAS, it appears necessary to reduce the speed limit on a portion of Spink County Roads to provide for the safety and welfare of the residents and travelers on the established South Dakota Department of Transportation detour for the US Highway 212 construction project,

NOW THEREFORE BE IT RESOLVED, by the Spink County Commission that the following 45 miles per hour speed zones are established on these specified road sections and that those speed zones shall replace and supersede all previously established speed zones:

- 1. County Road 13(392nd Ave) from US HWY 212 6 miles South to County Road 22(179th St)
- 2. County Road 22(179th St) from 392nd Ave 8 miles East to SD HWY 37

BE IT FURTHER RESOLVED, that this resolution shall be effective immediately upon publication pursuant to SDCL 9-19-13, for the immediate preservation of public safety.
